He has been charged for various DV offences and on the 10th of June his latest matter was dismissed at court as the victim did not show up. He has a lengthy history of complaining to anyone on one weekend alone sent our command over 11 emails. He has emailed LECC who have told him he will soon be blocked from their server so too has the ministers office.

These complaints are seem to be targeted at the victim in his various DV offences and he complains nothing is being done to arrest the victim and that Smith himself is the victim and not the offender.

In terms of his mental health he last presented to St Vincents Hospital in Darlinghurst in 2021, but a few months ago, he made some self harm threats via triple zero about jumping in front of a train. Since that time he has continued to complain about his court matter and using the complaint process to inform any government agency as to his innocence rather than presenting this evidence at court, as he has been informed. In the event his mental health potentially declines I am seeking some assistance from mental health team to contact, assess Mr Smith and determine the viability of any necessary follow up.

- Anthony is a 55 year old male with nil history on CIMHA he was referred to RACT by NSW Police Force due to calling 000 reporting suicide thoughts with plan to jump in front of the train.

- Phone rang and Anthony answered promptly. Introduction done and the reason of the call explained. Anthony reports that he was not aware that he has been referred to mental health. Anthony enquired who had referred him to MH. Anthony reports they have referred him to MH services before. States that it is unfair that they pass the bark to mental health service instead of them doing their job. Anthony gave consent to the assess. Anthony reports the following:-
 - he is currently living with a friend in Scarborough, he is not sure how long he will be staying there.
 - reports that he left NSW due identify theft.
 - reports he has been in contact with NSW Police Force due to an impostor/identity theft.
 - states that he has sent several email to NSW Police about the issues but they do not believe him and stating that he has mental health issues. States that it frustrating.
 - reports that he has history of PTSD but he is not paranoid.
 - reports that he currently engages with a psychologist and if he was paranoid his psychologist could have picked it up by now. States that he has had 10 session with the psychologist so far. States that if he was paranoid his psychologist should have picked it up.
 - reports that the impostor has been making his life difficult for him
 - states that in one of his conversation with NSW Police Force he threatened suicide. States that he was hoping that they will take his case seriously and from that telephone call he has been labelled as a suicidal person. States that he is not suicidal. States that he is actually on the run to save his life.
 - reports he is safer at his friends place while finding ways on how he can get help to get his back from the impostor.
 - Anthony reports that he is stressed but he has the support from his psychologist.
